

I received yesterday (May 2, 2012) the following letter from UK solicitors representing Vassula Ryden and the Foundation for True Life in God, demanding that I turn over to them the domain name Infovassula, because "Vassula" and "True Life in God" are registered international trademarks and I cannot use those words in my domain name. They state that I am using the domain name infovassula.ch as an instrument of fraud, because it contains negative information regarding Vassula. They claim they have been damaged because some of their followers didn't understand (!) that it is a critical website and not an official website of Mrs Ryden's. They also accuse me of trying to pass myself as a member of Vassula's organization! I'm not even going to comment the letter, just read it below.

Unfortunately, I can take no more of this. So, I am going to close the website at the end of May and unfortunately, since I do not have the means financially nor mentally to face another lawsuit (see <u>tliglawsuit.htm</u>), no matter how ridiculous it is, I am constrained to hand over the domain name to Vassula in June 2012. Infovassula will then cease to be a critical website and will join the cohort of pro-Vassula websites that proliferate in the Internet.

VASSULA/TLIG -V- M.L.PIO

We act for Vassula Ryden and the True Life in God Foundation (to whom we refer in this letter as Vassula and TLIG, collectively called "our clients").

For many years our clients have operated by reference to a distinctive name VASSULA, inter alia. For example, since 27th June 1997 the domain name VASSULA.ORG has been registered. A simple internet search via Google using the search term "Vassula" demonstrates this point. The results relate exclusively to our clients. As you are aware our clients promulgate the messages of Vassula throughout the world, including England and Wales, and have registered international trade marks for the protection of their intellectual property.

As a result of our clients activities they have a significant reputation in England and Wales, Europe and throughout the world in relation to Vassula's teachings. Such reputation has been spread by not only her appearances in England & Wales but also through her books, the internet, word of mouth, and of course the well-known presence she has on the international stage in these matters.

Our clients are aware of your use of the name Vassula on the www.infovassula.ch website. In view of the substantial good name and reputation in our clients' name Vassula in England and Wales, which has become distinctive of our clients, your use of VASSULA in the domain name is likely to cause confusion in the mind of the public, that the website is connected or associated with our clients. You are using our clients' distinctive name VASSULA, conjoined with the descriptive word "info". The continued use of this domain name to host a website is likely to cause substantial damage to our clients' reputation and goodwill. Since you registered the domain name www.infovassula.ch on 23 February 2007 you have used the site for the specific purpose of publishing negative material, observations and comment which are

confusing to those who read it and which are damaging to the international reputatio of Vassula and TLIG. By way of example

i) we are well aware that you published on this website between the 24 March and 14 April 2011 an untruthful report stating that Vassula had been excommunicated by the Holy Orthodox Church by virtue of a document published by the Ecumenical Patriarch of Constantinople. In consequence both members of TLIG and others were led to believe that Vassula had suffered the processes of excommunication from her own Church, contrary the truth. This misinformation published on the website you are using was believed to be true because of a widespread belief in England and Wales that your website was associated with Vassula and TLIG.

ii) In other instances, members of TLIG having read the contents of your statements published on this internet site have been led to believe that your statements carry the authority and approval of Vassula and in consequence their allegiance to Vassula and to TLIG has been undermined and has result in members forming the view that Vassula no longer holds to the beliefs

expressed in the messages.

Furthermore, the domain name "infovassula.ch" is an instrument of fraud in your hands in that, realistically, it can only be used to denote a connection to our clients. does not have an independent legitimate use, that refers to something other than our clients. Your name is not "Vassula" and not could you legitimately claim to wish to use or transfer the domain name to anybody by that name. It is the distinctive name of our client. This passing off is unacceptable to our clients and in the circumstance they require from you signed undertakings in the form attached to be returned to us no later than 4pm on the 20th day of May next. If you provide the undertakings in accordance with this request, our clients will bear their own legal costs incurred in this matter to date.

If proceedings in the High Court of England and Wales become necessary (which may be issued and served without further notice to you), the remedies that our client will seek include an injunction restraining your use of the domain name and its transfer to our clients, damages or an account of profits, legal costs and interest. A order made in the English High Court would be enforceable in Switzerland and elsewhere. In the meantime, our clients reserve all their rights in this matter.

This is a complex area of law and we strongly recommend that you seek independe legal advice immediately from a specialist English lawyer.

- iii) To transfer to the Claimants the domain name www.infoVassula.ch and all other domain names owned by me as of the 30th day of April 2012 containing the word Vassula by 4pm on the 20th day of June 2012
- iv) To provide to you by the 20th day of June 2012 a Schedule of benefits to the use of the domain name infoVassula.ch and any associated website.
- v) To provide a sworn statement to you by the 30th day of June 2012 confirming that I have complied fully and promptly with the obligations imposed by paragraphs i) to iv) above and the information supplied under paragraph iv is accurate and comprehensive.
